## WRIT DENIED

Relator, LHC Group, Inc., seeks review of the trial court's May 20, 2025 denial of its motion *in limine* to exclude hearsay evidence that Respondent, Laura M. Badeaux, allegedly fell on a chest tube in her husband's hospital room on October 24, 2022. It specifically contends that the EMS statements within the Ochsner medical records and the testimonies of Kelly Badeaux Phillips and Michelle Badeaux Stall about the chest tube being involved in the fall should be excluded. In its motion, Relator argued that the statements in Mrs. Badeaux's medical record that she fell on a chest tube are attributable to the EMS technicians, and those technicians were not present at the time of the fall. Thus, Relator averred that the declarant of the statement is unknown, and the statement is impermissible hearsay throughout Mrs. Badeaux's medical record. In regard to the testimonies of Mrs. Phillips and Mrs. Stall, Relator argued that they had no personal knowledge of what caused Mrs.

Badeaux's fall, and any statement about the chest tube causing Mrs. Badeaux's fall would be hearsay.

At this juncture, we find that the trial court did not abuse its discretion in these evidentiary rulings.<sup>1</sup> The evidence presented at trial by the parties will dictate whether there are any applicable hearsay exceptions. Accordingly, the writ application is denied.

<sup>&</sup>lt;sup>1</sup> Although Relator seeks to have any reference to the chest tube excluded from the testimonies of Mrs. Phillips and Mrs. Stall, the trial court only denied Relator's motion *in limine* for the text messages between Mrs. Phillips and Mrs. Stall on October 25, 2022 from 1:33 a.m. to 1:34 a.m. The court pretermitted a ruling on Mrs. Phillips' conversation with Ms. Badeaux right after the fall, Mrs. Phillips' conversation with LTAC personnel, the text messages between Mrs. Phillips and Mrs. Stall on October 25, 2022 at 9:34 p.m., and the collective testimonies of Mrs. Phillips and Mrs. Stall regarding Mrs. Badeaux's statement about the fall pending evidence submitted at trial.
