### WRIT DENIED

Relator, Clarence O. Gibson, seeks review of the trial court's October 21, 2025 denial of his application for post-conviction relief ("APCR"). In his APCR, Relator sought an out-of-time appeal to challenge his 2009 conviction and sentence for sexual battery. In its denial, the trial court found that Relator's APCR is timebarred pursuant to La. C.Cr.P. art. 930.8, and he is not entitled to another appeal or to any other judicial relief.

After review, we find that the trial court did not err in its denial of Relator's APCR. Relator received appellate review of his conviction and sentence in *State v*. *Gibson*, 09-486 (La. App. 5 Cir. 3/9/10), 38 So.3d 373, *writ denied*, 10-802 (La. 11/5/10), 50 So.3d 814. His conviction and sentence for sexual battery are now final. Once an appellate court renders judgment and that judgment becomes final, the criminal defendant no longer has a right to an appeal. *Gibson v. Twenty Fourth Jud.* 

Dist. Ct. of Jefferson Par., 25-118 (La. App. 5 Cir. 4/3/25), 2025 WL 1001180, writ denied, 25-474 (La. 9/24/25), 417 So.3d 51, citing State v. Howard, 53,104 (La. App. 2 Cir. 1/15/20), 289 So.3d 1176, 1179. Relator is not entitled to a second appeal.

Accordingly, the writ application is denied.
