WRIT DENIED

Defendant/relator, Derrick Chairs, again seeks review of the trial court's denial of his motion to quash. On November 13, 2025, we previously denied relator's writ seeking to review the trial court's denial of his motion to quash on the grounds that relator did not include copies of relevant pleadings for this Court to consider. *See Chairs v. State*, 25-540 (La. App. 5 Cir. 11/13/25) (unpublished writ disposition).

Relator has attached a copy of his motion to quash. However, relator has still failed to include a copy of (1) the judgment, order, or ruling of which relator seeks review; (2) the bill of indictment at issue; (3) a notice of intent, stating his intent to file this writ application and requesting a return date; and (4) an order

from the trial court setting a return date for relator to file this writ application. *See* Rules 4-2, 4-3, and 4-5 C(7), (8), and (9) of the Uniform Rules-Courts of Appeal.

Thus, this Court is presented with nothing to review. Accordingly, on the showing made, we deny this writ application.
