WRIT DENIED

Relator, Colon Neely, seeks review of the district court's ruling increasing his bond. In his application, relator references an October 1, 2025 ruling by the district court which increased his bond from \$160,000 to \$300,000. However, relator has failed to provide this Court with a copy of the ruling complained of, a copy of the pertinent court minutes, a copy of a notice of intent filed with the trial court, documentation pertaining to a return date as required by Uniform Rules-Courts of Appeal Rules 4-2, 4-3, and 4-5. This Court has denied writ applications with similar defects because they provided nothing for the Court to review. *See Tori Jones v. 24th Judicial District Court*, 23-436 (La. App. 5 Cir. 9/20/23)(unpublished). Similarly, the present application is deficient in that it fails to provide the documents necessary for review. On the showing made, relator is not entitled to the requested relief. Accordingly, this writ application is denied.
