WRIT DENIED

In this *pro se* writ application, defendant/relator, Celius Gray, asserts the trial court has not ruled on his motion to withdraw plea of not guilty by reason of insanity filed on February 9, 2026 and seeks a ruling relative thereto.

On November 13, 2024, the trial court found defendant lacks the mental capacity to understand the proceedings against him or to assist in his defense and remanded him to the Eastern Louisiana Mental Health System. A hearing is currently set in this case for May 6, 2026.

When the question of the defendant's mental incapacity to proceed is raised, there shall be no further steps in the criminal prosecution, except the institution of

prosecution, until the defendant is found to have the mental capacity to proceed. La. C.Cr.P. art. 642. If the court finds that defendant lacks the mental capacity to proceed, the proceedings shall be suspended. La. C.Cr.P. art. 648(A).

Because the trial court has found defendant lacks the mental capacity to proceed, the proceedings in this case are suspended. The trial court currently cannot rule on defendant's motion. Thus, defendant is not entitled to relief. We therefore deny this writ application.
