## WRIT DENIED

Relator, Clayton Cangelosi, seeks review of the trial court's January 28, 2026 oral ruling granting defendant, OnPath Federal Credit Union's motion to compel.

Upon review, we find relator's writ application is deficient. Relator has failed to include (1) the signed judgment, order, or ruling of which relator seeks review;<sup>1</sup> or (2) a minute entry or transcript reflecting the trial court's oral ruling. La. U.R.C.A., Rule 4-5.

Accordingly, on the showing made, relator's writ application and motion for stay are denied.
